The Important Fine Print

Fees, rates, and specifications are subject to change. Prices quoted are per person and based upon special rates negotiated with the airlines and other suppliers, and require a fare guarantee deposit (included in your initial deposit). The air tickets issued are restricted economy class, non-refundable, and require advance purchase. Prices quoted are based upon a group size of 25 or more people. Should the group size drop below 25 people for any segment, a rate increase of approximately \$95 will occur. The current total amount (on September 1, 2008) for security fees, fuel surcharges, and passenger facility charges (Airport taxes and security fees) **is included** in the trip fees above. Other fees that may be imposed by the airlines or other authorized agencies are not included This fee is subject to change.

The final occupancy of a unit determines the rate per person. The balance due on November 8, 2008 will be based on the group size, and your rooming arrangements at that time. Adjustments to your balance caused by changes in airport taxes and fees, rooming arrangements, or group size, may occur and will be credited back or due before departure. Your deposit, less a \$75 administrative fee and \$50 fee imposed by tour suppliers (total \$125), is refundable if written notice of cancellation is received 90 days (November 8, 2008) before departure. Fees and charges for cancellations received within 90 days of the trip will range from a minimum of \$500 to the full amount of the trip. Complete details are available from our office.
